- 1. Each Sheriff has received a Certification Letter, Explanation and Attestation Form that is sent to Sheriff's Offices every four years. Each county is then required to determine whether or not they are compliant with the requirements and standards established by the Council based on the box they check on the Attestation Form, which must be completed and returned to MSCTC. Your assistance in completing and submitting the Attestation Form is greatly appreciated.
- 2. As a follow-up to the Council's interim policy changes regarding the pre-hire EMPCO Written Exam that took effect on August 1, 2021, we have asked each Sheriff's Office to provide MSCTC with their Minimum passing score for the Written Exam. Please make sure to submit your minimum passing score to us as soon as possible.

MSCTC On-Line In-Service Training DACOTA Spotlight – October 2021

Through a training partnership with MSCTC, the National Institute for Jail Operations provides Michigan agencies with engaging legal-based online training through DACOTA—NIJO's Detention and Corrections Online Training Academy. All DACOTA curriculum is approved for all levels of NIJO Professional Certification (NCCO, NCCS, and NCCE).

Currently, the DACOTA Catalog contains 69 online courses providing 75 CEUs of corrections-specific training based on what the law requires for running safe and secure facilities. As of the end of October, Michigan DACOTA online learners have completed 4,509 courses and 4,917 credit hours. Currently, 39 Michigan agencies have learners getting trained in the DACOTA platform. 


DACOTA Course Spotlight

Social Intelligence (1.5 CEUs) Instructor: Dr. Steve Sampson

Social Intelligence is about understanding your environment and then having a positive influence in it. This online course covers what skills are required to be "socially-fit" including:

- Positive Non-Verbal Behaviors (i.e Kinesics; Proxemics, Facial Expression),
- Positive Paralanguage (i.e. Voice Tone, Volume, Pitch), and
- Positive Verbal Behaviors (e.g. saying the right thing at the right time).





Dr. Steve Sampson has been teaching social intelligence, and leadership skills for over 45 years. He holds a Bachelor's Degree in Sociology from the University of Massachusetts (1970) and a Masters (1976) and Doctoral Degree (1981) in Counseling Psychology from Georgia State University. He is a nationally recognized Master Trainer in Interpersonal Communication Skills since 1977, and has presented that training to over 300 agencies and organizations in 40 states. He is a former Assistant Professor of Criminal Justice at Georgia State University from 1979 to 1985. In 2004, he retired from his position as a Clinical Professor in the Counseling Psychology at Georgia State University (1995-2004). He recently retired as Executive-in-Residence Professor at the College of Justice and Safety at Eastern Kentucky University (2009-2016) where he developed an Institute for Social Intelligence and Leadership.

Director of Training Report

WHY IS CORRECTIONS OFFICER TRAINING SO IMPORTANT?

Why should Sheriff's Offices train their Correctional Staff? If you have been involved in a civil or criminal liability case, you probably already know the answer. One of the first items plaintiff and defending attorneys seek in a Corrections lawsuit is training records. What has your staff been trained in? Where was the training conducted? Who conducted the training and what are their instructor credentials? And don't forget the documented proof of training and attendance!

The following items are the most looked at aspects in lawsuits by the courts:

- Negligent Appointment: Is your Agency delinquent in the hiring process that hired the individual(s) involved in the lawsuit?
- Negligent Retention: Courts look at if your Agency continued employing the staff involved even though they should have been terminated.
- Negligent Assignment: Did the Supervisor that assigns daily duty assignments knowingly assign any of the staff involved irresponsibly, knowing that these Officers were not able to carry out their assignment(s) properly and safely?
- Failure to Supervise: Did on-duty and assigned Supervision fail to oversee those in their charge and involved in the lawsuit?
- And the #1 most important aspect in Correctional lawsuits, Failure to Train: This
 interrelates with all the above areas of importance. Did the involved Agency poorly
 train or fail to train the staff involved in the lawsuit?

It is vital that Agency's monitor and are aware of the methods and objectives used in the training programs used to achieve the training objectives. Instructor qualifications should be documented and valid. Training should be consistent with Agency need, certification and re-certification requirements, and equal to or above industry standards. And lastly, training should be documented with attendance records.

In-service and Academy training should not just be done to check of the obligatory box of requirement, it should also be conducted to inform and protect you, your staff, and your Agency.

NIJO and MSCTC are proud to recognize the following individuals who have earned NIJO Certification for corrections professionals. All were recognized recently during the National Corrections Professionals Awards Ceremony held during the JAILCON21 Online Conference on October 26, 2021.

NIJO's certification curriculum is uniquely based on what the law requires, rather than best practices that may be subjective or based on opinion. NIJO Certification requires a score of 100% on comprehension testing to receive certification credit which provides an added level of confidence in defending against frivolous litigation attacks on incomplete or inadequate training. NIJO offers 3 distinct levels of certification, for officers, supervisors, and executives. National Certified Corrections Officer (NCCO) requires 40 hours of legal-based training, National Certified Corrections Supervisor (NCCS) requires 70 hours of legal-based training, and National Certified Corrections Executive (NCCE) requires 115 hours of legal-based training.

NIJO Legal-Based Jail Guideline: C05.02.02: Inmate Rules and Regulations

KEY ISSUE:

Inmates not having access to a handbook means they either don't know the rules and regulations of a facility or they will have to ask someone else who does know the ins and outs. That person, which may be a fellow inmate or a staff member, may or may not explain those rules and regulations correctly or fully. But not having the handbook also creates more issues than just simple rule violations.

It is necessary that inmates have fair notice concerning both required and prohibited conduct. Such notice is particularly important in the disciplinary process, where rules and regulations are a critical element in ensuring due process. Without having access to rules and regulations, how can an inmate be fairly disciplined?
